RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE is given as of this 19 day of September, 2008 by France Telecom Technologies Investissements, a French corporation located at 23 rue Royale 75008 Paris France ("Assignor"), in favor of Jabber, Inc. as successor-in-interest to Jabber.com, Inc., a Delaware, USA corporation located at 1899 Wynkoop Street, Suite 600, Denver, CO 80202 USA ("Assignee"), as follows:

WHEREAS, Jabber.com, Inc. entered into an agreement with Assignor pursuant to which it provided Assignor with a security interest in certain of its trademarks (the "Security Agreement"), which is recorded with the United States Patent and Trademark Office at Reel 2333/Frame 0037;

WHEREAS, pursuant to the Security Agreement, Jabber.com, Inc. granted to Assignor a security interest in and continuing lien upon any and all right, title, and interest of Jabber.com, Inc. in and to the trademark registrations set forth on Schedule A attached hereto (the "Trademarks"), among other collateral;

WHEREAS, Assignee, which is the current record owner of the Trademarks, is the successor-in-interest to Jabber.com, Inc., and to Jabber.com, Inc.'s rights and obligations under the Security Agreement; and

WHEREAS, Assignee, as successor-in-interest to Jabber.com, Inc., has satisfied its obligations under the Security Agreement and Assignor desires to release its security interest in and continuing lien upon the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest in and lien upon the Trademarks and assigns any and all interest that it may have in the Trademarks to Assignee.

Any capitalized terms used but not defined herein shall have the respective meanings assigned to them in the Security Agreement.
