**RELEASE OF PATENT, TRADEMARK AND COPYRIGHT COLLATERAL
ASSIGNMENT AND SECURITY AGREEMENT**

THIS RELEASE OF PATENT, TRADEMARK AND COPYRIGHT COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT is made as of September 24, 2008, by National City Business Credit, Inc. ("Lender").

W I T N E S S E T H

WHEREAS, Company has requested that Lender release its security interest in the Patents, Trademarks and Copyrights (as said terms are defined in the Security Agreement), including the intellectual property described on Exhibit A, Exhibit B, and Exhibit C hereto, and reassign the same to Company;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby relinquishes, releases and discharges its security interest in all of Company's right, title and interest in and to the Patents, Trademarks and Copyrights, and in the case of the Trademarks, in and to the goodwill of the Company symbolized thereby, including, without limitation, the intellectual property described on Exhibit A, Exhibit B, and Exhibit C, hereto.

2. Lender hereby reassigns, grants, and conveys to Company, all of Lender's right, title and interest in and to the Patents, Trademarks and Copyrights, and in the case of the Trademarks, in and to the goodwill of the Company symbolized thereby.


