TRADEMARK ASSIGNMENT

WHEREAS, The Floor Covering Consumer Credit Association, Inc. (hereinafter the "Assignor"), a corporation organized and existing under the laws of the State of PA, with its principal office and place of business located at 13324 MILLBURN DR PLAZA FIELD, IL (hereinafter the "Assignor"), is the sole owner of the entire right, title and interest in and to marks identified in Exhibit A hereto (hereinafter the "Marks"), together with the goodwill of the business in connection with which the Marks are used; and

WHEREAS, CCA Global Partners, Inc., a corporation, organized and existing under the laws of the State of Missouri, with its principal office and place of business located at CCA is 4301 Earth City Expressway, Earth City, MO 63045, (hereinafter the "Assignee"), is desirous of acquiring the entire right, title and interest in and to the Marks, together with the goodwill of the business in connection with which the Marks are used; and

WHEREAS, Assignor desires to transfer all of its right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used.

NOW, THEREFORE, for five hundred dollars (\$500) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers and assigns to Assignee its entire worldwide right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used, including all registrations and applications therefor, as well as all renewals and extensions of registrations that are or may be secured by Assignee, its successors, assigns or other legal representatives, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Marks, with the right to sue for injunctive relief, damages, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

AND Assignor represents and warrants that: (i) it has not mortgaged, pledged, or otherwise encumbered the Mark, or any goodwill associated with the Mark; (ii) it has not authorized any licensees or other third parties to use the Mark; (iii) no litigation or administrative process is pending with respect to the Mark; and (iv) to its knowledge, no claim or threat has been or is about to be made with respect to the Mark. Assignor further represents and warrants that it has the exclusive right to and owns all rights in and to the Mark and assignment and use of the Mark under the terms of this Agreement will not infringe any intellectual property of any third parties.

AND Assignor hereby covenants and agrees that it will execute any and all instruments and documents reasonably necessary to aid the Assignee, its successors, legal representatives, and assigns, in the implementation and recordation of this Assignment.

This assignment is effective as of this 19th day of September, 2008.
