RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of September 19, 2008 (this "Release") is made by THE TORONTO-DOMINION BANK, acting in its capacity as administrative agent (in such capacity, the "Secured Party") under that certain Security Agreement, dated as of March 29, 2007 and recorded in the records of the United States Patent and Trademark Office at Reel 003569, Frame 0059 on June 21, 2007 (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among Earl Street Capital, Inc., Koch Entertainment LP, Koch Entertainment GP LLC and Gaylord Production Company (collectively, the "Debtors") and the Secured Party;

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party a continuing security interest in all of the Debtors' United States trademarks, including but not limited to those listed in the attached schedules (collectively, the "Trademark Collateral"); and

WHEREAS, the Secured Party wishes to: (i) terminate the Security Agreement against the Trademark Collateral; (ii) release all of its security interest in the Trademark Collateral; (iii) restore to the Debtors all right, title and interest in and to the Trademark Collateral; and (iv) dissolve any and all of its liens and encumbrances against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby: (i) terminate the Security Agreement against the Trademark Collateral; (ii) release all of its security interest in the Trademark Collateral; (iii) discharge, quit claim and relinquish unto the Debtors (in each

case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Trademark Collateral; and (iv) dissolve any and all of its liens and encumbrances against the Trademark Collateral.

The Secured Party shall take any and all reasonably required further actions, and provide to the Debtors and each of their respective successors, assigns, designees or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Debtors to more fully and effectively effectuate the purposes of this Release.


