ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

ASSIGNMENT dated as of September 26, 2008, from Bear Stearns Corporate Lending Inc., as initial collateral agent (the "Initial Collateral Agent"), to BNP Paribas, as successor collateral agent (together with its successors and assigns, the "Successor Collateral Agent").

WITNESSETH:

WHEREAS, pursuant to that certain First Lien Trademark Security Agreement, dated as of June 20, 2006 (the "Trademark Security Agreement"), by and among Quality Home Brands Holdings LLC, a Delaware limited liability company and each of the other signatories thereto (individually, as a "Grantor" and collectively, as the "Grantors") and the Initial Collateral Agent, the Grantors granted a security interest to the Initial Collateral Agent in certain Collateral including the Trademarks set forth on Schedule A thereto; and

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on July 10, 2006, at Reel 3344, Frame 0814; and

WHEREAS, the Initial Collateral Agent has assigned all of its rights, powers and privileges as Collateral Agent under the Credit Agreement (as such term is defined in the Trademark Security Agreement) and the Trademark Security Agreement to the Successor Collateral Agent; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Assignment, the Initial Collateral Agent hereby acknowledges and agrees as follows:

1. Definitions. The term "Trademarks" shall have the meaning ascribed to it in the Trademark Security Agreement, and includes, without limitation, those items listed on Schedule A hereto.
2. Assignment of Security Interest. The Initial Collateral Agent hereby assigns all of its rights, powers and privileges under the Trademark Security Agreement, including those respecting the Trademarks and Trademark applications and registrations, to the Successor Collateral Agent.
3. Further Assurances. The Initial Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect this Assignment.
