## **AFFIDAVIT OF OWNERSHIP**

2. Through a series of name changes, Pharmacia & Upjohn S.A., became Pharmacia Enterprises and then Pfizer Enterprises SARL as evidenced by copies of the certification documents attached hereto.

3. All intellectual property under the name of Pharmacia & Upjohn S.A. and subsequently, Pharmacia Enterprises transferred to Pfizer Enterprises SARL by virtue of the changes of name as evidenced by filings with the United States Patent and Trademark Office under REEL/FAME Nos. 2883/0023, 3454/0728, 2883/0588 and 3411/0725.

4. On April 16, 2003, an assignment between Philadelphia International Medicine LLC and Hospital & Healthsystem Association of Pennsylvania was improperly filed and recorded with the Assignment Division of the United States Patent and Trademark Office against

the registered mark under REEL/FRAME No. 2714/0754. This assignment should be removed from the chain of title.

5. As the true chain of title has been established for the registered mark and the owner has been and continues to be Pfizer Enterprises SARL, including the date of filing of the Combined Affidavit, the incorrect assignment should not be considered to have altered the ownership of the registered mark.


