**WHEREAS**, Assignee desires to obtain from Assignor all of Assignor's rights in and to the Marks;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby sell, assign, transfer and set over to Assignee all right, title, goodwill and interest in and to the Marks.



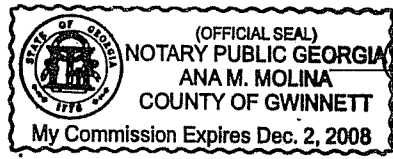

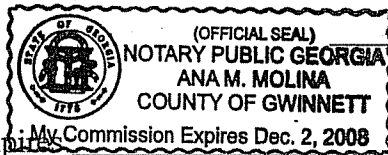
