NOW THIS DEED WITNESSES:



At the request and at the expense of the Assignee, the Assignor will do all reasonable acts, execute all documents and procure the making of any declarations or oaths necessary or required by law for further effecting the transfer of the Registrations to the Assignee and assisting the Assignee in recording the transfer of the Registrations.
4. It is hereby certified that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds sixty thousand British Pounds.


