## TRADEMARK ASSIGNMENT

WHEREAS ASSIGNOR acknowledges and agrees that it shall execute all such other documents, and take all such further actions, as the ASSIGNEE may reasonably request in order to effectuate the terms and purposes of this Assignment, in accordance with Section 6.1 of the Agreement; and

WHEREAS ASSIGNOR does hereby constitute and appoint ASSIGNEE, its successors and assigns, as ASSIGNOR's true and lawful attorney, with full power of substitution, for ASSIGNOR and in its place and stead or otherwise, by and on behalf of and for the benefit of ASSIGNEE, its successors and assigns, to execute all such other documents, take all such further actions and from time to time to institute and prosecute in its name or otherwise, for the benefit of ASSIGNEE and its successors and assigns, any and all proceedings at law, in equity or otherwise, which ASSIGNEE, its successors or assigns shall deem advisable in connection with the Trademarks and corresponding domain names identified on Schedule A hereto, ASSIGNOR hereby declaring that the appointment hereby made and the powers hereby granted are coupled with an interest and are and shall be irrevocable by ASSIGNOR in any manner or for any reason.

NOW THEREFORE, in consideration of the foregoing, as well as other good and valuable consideration the receipt and adequacy of which is hereby freely acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over to ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest of ASSIGNOR in and to said Trademarks and corresponding domain names, together with the business and the good will of the business in connection with which the said Trademarks have been used or intend to be used,

and all claims, if any, which may have arisen thereunder prior to the date of this instrument.
