

PLAN OF ENTITY CONVERSION

a Virginia corporation

- 1. <u>The Parties</u>. Style, Inc., a Virginia corporation (the "Corporation"), is proposing to convert to Style, LLC, a Virginia limited liability company (the "LLC") pursuant to Section 13.1-722.9(A) of the Virginia Code.
- 2. <u>Effective Date</u>. This entity conversion shall be effective on the date that a Certificate of Entity Conversion is issued by the Clerk of the Virginia State Corporation Commission (the "Effective Date").
- 3. <u>Conversion of Shares into Membership Interests</u>. The Corporation's sole shareholder shall become the LLC's sole member. On surrender of the certificates representing the shares of stock in the Corporation outstanding immediately before the Effective Date, the interest in the LLC shall be deemed to have been issued in exchange therefor in accordance with the provisions set forth above.

If at any time the LLC shall consider or be advised that further assignments, conveyances or assurances are necessary or desirable to vest, perfect or confirm the LLC with title to any property or rights of the Corporation, or otherwise carry out the provisions hereof, before the Effective Date the proper officers and directors of the Corporation and thereafter the manager of the LLC, acting on behalf of the Corporation shall execute and deliver any and all proper assignments, conveyances and assurances and do all things necessary or desirable to vest, perfect or confirm the LLC with title to such property or rights and otherwise carry out the provisions hereof.
- 7. <u>Abandonment</u>. This Plan of Entity Conversion may be terminated and the conversion abandoned at any time before the Effective Date by action of the Board of Directors of the Corporation.
