


WHEREAS, said Trademark Security Agreement was recorded in the United States Patent & Trademark Office on November 23, 1999 at reel/frame 1998/0171; and

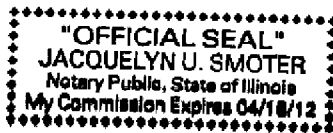
