DEED OF ASSIGNMENT

This Deed is dated11.9.08.....

BETWEEN Sabre Corporation Pty Ltd (ACN 002 761 426) of 75 South Creek Road, Dee Why NSW 2099 (*Sabre*)**AND** Lionel David Bloom of 26 Binncy Road, Kings Park NSW 2148 (*Assignee*)**Background**

- A Sabre owns the registered trade marks specified in the Schedule (*Trade Marks*).
- B Sabre and the Assignee have entered into a Sale Agreement dated on or about the date of this Deed, pursuant to which Sabre has agreed to sell the Trade Marks (amongst other things relating to the brand "Squirt"), to the Assignee (*Sale Agreement*).
- C The parties have agreed to enter into this Deed to formally assign the Trade Marks from Sabre to the Assignee.

IT IS AGREED THAT:**1. ASSIGNMENT OF TRADE MARKS**

- 1.1. Subject to completion of the sale in the Sale Agreement, Sabre assigns the Trade Marks to the Assignee absolutely, free of all encumbrances and third party interests, including all of the common law rights and reputation subsisting in and to the Trade Marks, and the right to sue for infringements that occurred prior to this Deed, effective as at 11 September 2008.
- 1.2. The parties agree that upon this assignment the Assignee shall be solely entitled to take such action as it sees fit in respect of any past, present or future infringement of the Trade Marks.
- 1.3. The parties agree that any assignment of the Trade Marks pursuant to clause 1.1 will be subject to and on the terms and conditions of this Deed and the Sale Agreement.

2. GENERAL

- 2.1. This Deed is governed by and will be construed according to the laws of New South Wales, Australia.


