ASSIGNMENT OF TRADEMARKS AND TRADE NAMES

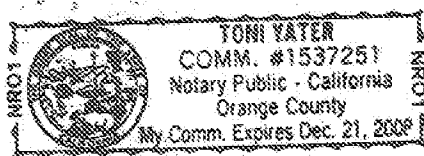
