Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the Corporation is GRATE TECHNOLOGIES, INC.
2. Article 1 of the Articles of Incorporation is hereby revoked and the following Article 1 is inserted in lieu thereof:

"ARTICLE 1.

The name of the Corporation is LAWSON AQUATICS, INC."
