ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks is made between (1) Tanatex IP B.V., a Dutch limited liability company having its principal place of business at Einsteinstraat 11, 6716 AC EDE, The Netherlands; and (2) LANXESS Corporation, a Delaware corporation having its principal place of business at 111 RIDC Park West Drive, Law and Intellectual Property Dept., Pittsburgh, Pennsylvania 15275-1112.

WHEREAS, LANXESS Corporation ("Assignor") has adopted, owns and is using in connection with its business activities the trademarks (1) "TANAPRINT" which has been registered for the United States for goods in International Class 2 under U.S. Trademark Registration No. 951,649; and (2) "TANATEX" which has been registered for the United States for goods in International Class 1 under U.S. Trademark Registration No. 1,367,241 (hereinafter collectively referred to as "the Trademarks"); and

WHEREAS, Tanatex IP B.V. ("Assignee") is desirous of using the Trademarks and acquiring the entire right, title and interest thereto, and the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, and as agreed to by the parties in the MASTER SALE AND PURCHASE AGREEMENT between the parties dated November 10, 2006, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby sells, assigns, conveys and transfers unto Assignee all right, title and interest in, to and under the Trademarks together with (a) all associated common law rights, (b) the goodwill of the business symbolized thereby, and (c) all rights and privileges granted and secured thereby, including, without limitation, corresponding U.S. trademark registrations, the right to sue and recover for any past or continuing infringement of the Trademarks, as well as the right to seek any and all remedies available at law or in equity;

2. all said right, title and interest shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the

same would have been held and enjoyed by Assignor if this Assignment of Trademarks had not been made.
