US TRADEMARK RELEASE DEED

TERMINATION OF SECURITY INTEREST

This Termination of Security Interest, dated as of October 2, 2008, is made by Silver Point Finance LLC, as Security Agent (“Grantee”) in favor of Jil Sander AG, a company incorporated under the laws of Germany (“JSAG”).

WHEREAS, pursuant to the Intellectual Property Security Agreement dated as of August 3, 2007 between Grantee and JSAG (the “Security Agreement”) recorded with the United States Patent and Trademark Office on August 9, 2007 at Reel No. 003598 and Frame No. 0214, JSAG granted to Grantee a security interest in certain trademark registrations and applications and the goodwill associated therewith, including without limitation the trademark registrations, applications and goodwill listed on Schedule I hereto (the “Marks”); and

WHEREAS, Grantee, on behalf of all of the Secured Parties (as defined in the Security Agreement) hereby confirms that the security interest in all of the Marks has been discharged, terminated and released in all respects.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Grantee hereby (1) releases, discharges and relinquishes its security interest in and lien on all of the Marks, and (2) reassigns to JSAG all right, title, and interest of Grantee in and to such the Marks, including all goodwill associated with the Marks. Grantee specifically acknowledges that the Security Agreement is no longer effective as to the Marks, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Marks.

Grantee acknowledges and confirms that the terms and conditions of this Termination of Security Interest shall be effective evidence of the release of the security interests in the Marks.
