## TRADEMARK SECURITY AGREEMENT

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, ThePlanet.com Internet Services, Inc., a Delaware corporation (the "Grantor"), with principal offices at 315 Capitol, Suite 205, Houston, Texas 77002, hereby grants to Wachovia Bank, National Association, as Administrative Agent, with principal offices at 2800 Post Oak Blvd., Suite 3400, Houston, Texas 77056, (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

This grant is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the Security Agreement among the Grantor and the Grantee, dated as of October 10, 2008 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). After the Security Agreement has terminated pursuant to its express terms, the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks acquired under this grant.


