TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST is made as of October 20, 2008 by GENERAL ELECTRIC CAPITAL CORPORATION, as Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and LT LLC ("Grantor"), were parties to that certain Trademark Security Agreement dated as of August 15, 2007 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Agent in, among other things, the Trademarks set forth on Schedule I hereto as security for certain obligations owing by Grantor to the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement dated as of August 15, 2007 by and among Grantor, certain of its subsidiaries, Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on August 15, 2007 at Reel 003602, Frame 0511; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to all of the following (the "Trademark Collateral"):

(a) each Trademark listed on Schedule I annexed hereto, together with any reissues, renewals, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all income, royalties, Proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral, and the goodwill of Grantor's business connected with the use of and symbolized by the Trademark Collateral.
