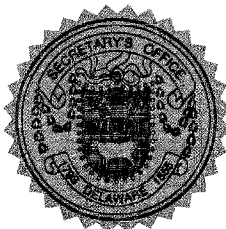

FIRST: The name of the Corporation immediately prior to filing this Certificate of Conversion is Harrow Products, Inc.

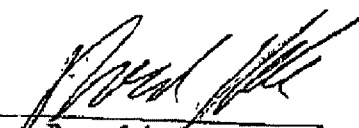
