CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment (this "Assignment") is made on October 17, 2008 by and between Robert Bosch LLC, a limited liability company organized and existing under the laws of Delaware with its principal offices located at 2800 South 25th Avenue, Broadview, Illinois 60155 ("Assignor") and BSH Home Appliances Corporation, a corporation organized and existing under the laws of Delaware with its registered office at 5551 McFadden Avenue, Huntington Beach, California 92649. ("Assignee").

WHEREAS, the Assignor was the owner of all right, title and interest in and to the Trademark listed on the attached Exhibit A (hereinafter, the "Mark"); and

WHEREAS, Assignor was desirous of assigning, and Assignee was desirous of obtaining, all right, title and interest in and to the aforementioned Mark; and

WHEREAS, effective as of April 7, 2008, Assignor assigned all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, to Assignee, but a formal written assignment was not executed in a recordable form; and

WHEREAS, the parties now wish to confirm the actual and legal transfer of the Mark from Assignor to Assignee;

NOW, THEREFORE, for good and valuable consideration previously paid, the sufficiency and receipt of which are hereby acknowledged, it is confirmed that effective as of April 7, 2008, Assignor did assign, transfer and convey, and hereby *nunc pro tunc* assigns, transfers and conveys, unto Assignee, all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement by the Mark, with the right to sue for, and collect the same for its own use and on behalf of its own successors, assigns, or other legal representatives.

2. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

3. This Assignment may be supplemented by further documentation executed by one or more of the parties, which documentation may be required in certain jurisdictions for recordation of this Assignment with the applicable governing authority.
