**RELEASE AND TERMINATION OF SECURITY INTEREST
IN TRADEMARKS**

This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS ("Termination and Release") is executed as of October ~~14~~, 2008, by Oligors and Bank of America, N.A., as administrative agent (the "Lender") with reference hereby made to that certain Amended and Restated Security and Pledge Agreement, dated as of May 6, 2005 (the "Security Agreement"), among American Color Graphics, Inc., a New York Corporation (the "Borrower"), and Lender (collectively, the "Parties").

WHEREAS, the Lender has recorded security interests in Borrower's trademarks set forth in Schedule A hereto (the "Trademarks") pursuant to those certain Notice of Grant of Security Interest in Trademarks dated July 3, 2003 and May 6, 2005 between American Color Graphics, Inc., and Lender (the "Trademark Security Agreement");

WHEREAS, such security interests were recorded in the Trademark Division of the United States Patent and Trademark Office, on July 9, 2003, at Reel 2777, Frame 0731 and on May 18, 2005, at Reel 3087, Frame 0158; and

WHEREAS, the Borrower wishes to record the release of the security interests of the Lender granted under the Security Agreement in connection with the Trademarks, and the Lender has agreed to execute such release documentation.

NOW THEREFORE, for good and valuable consideration, the Parties to this Termination and Release intending to be legally bound, agree as follows.

1. The Lender hereby releases in its entirety any and all security interests it has in the Trademarks, including in any goodwill, and the Lender hereby agrees to take any actions and to execute any further documents necessary or reasonably requested by the Borrower to effectuate or evidence such release, including, but not limited to, the execution and delivery of those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law.
2. The Parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record this Termination and Release.
3. This Termination and Release shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflict of law principles thereof.
4. This Termination and Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the Parties hereto or their respective successors and assigns.
5. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the Parties hereto.
