AMENDED AND RESTATED

TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Bernard Chaus, Inc., a New York corporation, S.L. Danielle Acquisition, LLC, a New York limited liability company and Cynthia Steffe Acquisition, LLC, a New York limited liability company, each located at 800 Secaucus Road, Secaucus, New Jersey -07094 ("Company"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, the Company is obligated to The CIT Group/Commercial Services, Inc. ("CIT"), as agent for the lenders ("Agent") and CIT and the other financial institutions as lenders (the "Lenders") pursuant to (i) a certain Amended and Restated Financing Agreement, dated the date hereof, between the Lenders and the Company and (ii) a certain Amended and Restated Grant of Security Interest in Patents, Trademarks and Licenses, dated the date hereof, made by the Company in favor of the Lenders (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, the Company is granting to the Lenders a security interest in certain of the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Company does hereby assign unto the Lenders and grant to the Lenders a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.

This Amended and Restated Trademark Assignment of Security amends and restates in its entirety and is given in substitution for (but not in satisfaction of) that certain Trademark Assignment of Security dated September 27, 2002.






