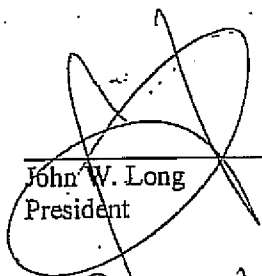
1. They are President and Secretary, respectively, of CIC, Inc., a Florida corporation (the "Corporation").

"The name of the Corporation shall be 'HireCheck, Inc.'"

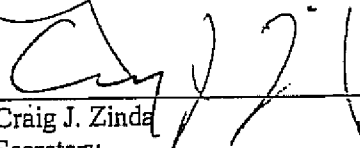
3. The foregoing amendment of the Articles of Amendment of Articles of Incorporation has been duly approved and adopted by the board of directors on August 18, 2000.
