

**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

WHEREAS, by that certain Intellectual Property Security Agreement dated as of November 19, 2004 ("IP Security Agreement"), recorded in the Patent Assignment database of the United States Patent and Trademark Office ("PTO") on November 29, 2004 at Reel/Frame 015394/0434 and recorded in the Trademark Assignment Database of the PTO on December 10, 2004 at Reel/Frame 2988/0157, Hospitality Mints, LLC, a Delaware limited liability company with an address at P.O. 

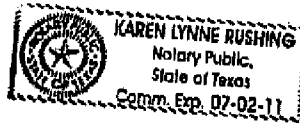
