CERTIFICATE OF RESTATEMENT OF  
ARTICLES OF INCORPORATION OF  
EDIFECS COMMERCE, INC.

Pursuant to the provisions of RCW 23B.10.060 of the Washington Business Corporation Act, the following Certificate of Restatement of the Articles of Incorporation of Edifecs Commerce, Inc. (the "Corporation") is submitted for filing.

**FIRST:** The name of the Corporation was Edifecs Commerce, Inc., and, upon effectiveness of the amendment filed herewith, shall be renamed Edifecs, Inc.

**SECOND:** Article 1 of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended to read as follows:

The name of the corporation is "EDIFECS, INC."

**THIRD:** This amendment was adopted by the Board of Directors of the Corporation on September 15, 2000 and duly approved in accordance with the provisions of RCW 23B.10.020 and 23B.10.070. No Shareholder action is required.

**FOURTH:** The Amended and Restated Articles of Incorporation so adopted read in full as set forth in Exhibit A attached hereto and are hereby incorporated herein by this reference.

**FIFTH:** The amendment referenced above is the only amendment contained in the Amended and Restated Articles of Incorporation and does not provide for any exchange, classification or cancellation of issued shares.
