RELEASE AND TERMINATION OF TRADEMARK SECURITY INTEREST

This RELEASE AND TERMINATION OF TRADEMARK SECURITY INTEREST ("Termination and Release") is executed as of October 21, 2008, by Mast Capital Management, LLC, as Collateral Agent (the "Agent"), in favor of Lev Pharmaceuticals, Inc., a Delaware corporation (the "Pledgor").

This Termination and Release shall be governed by the laws of the State of New York and shall relate solely to the Trademark Security Agreement.
