TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made this ~~September~~ ^{October} 1st, 2008 by Severstal Wheeling Holding Company, a Delaware corporation ("Assignor"), in favor of Bouchard Group, LLC, an Illinois Limited Liability Company ("Assignee").

WHEREAS, Assignor has agreed to sell, transfer, deliver and assign to Assignee, all of its right, title and interest in and to the trade name, trademark, service mark, trade dress, trade style, logo, design and/or slogan, in word mark, stylized and/or design formats, which is described and/or otherwise the subject of the registrations identified in Exhibit A, attached hereto and incorporated by reference herein (the "Mark");

WHEREAS, Assignee has agreed to pay Assignor the sum of fifty thousand dollars (\$50,000.00) in exchange for Assignor's assignment and transfer of the Mark;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. Assignor hereby irrevocably sells, transfers, assigns, conveys, sets over and delivers to Assignee, its successors and assigns, free and clear of all liens, pledges, charges, claims, security interests, options, mortgages, rights of first refusal or similar restrictions (except for (a) the pledge and security agreement in favor of JP Morgan Chase dated May 8, 2007, and assigned to General Electrical Capital Corporation on March 24, 2008, and (b) the security interest in favor of Essar Steel Holdings Limited dated May 5, 2008, and assigned to OAO Severstal on August 14, 2008, the latter of which Assignor will use its reasonable efforts to have released as soon as practical following the date of this Assignment), all of Assignor's right, title, and interest of whatever kind in and to the Mark together with the goodwill of the business symbolized by the Mark and any renewals that may be granted thereon, and all rights, claims and privileges pertaining thereto, including, without limitation, Assignor's right to sue for and collect damages and other recoveries for past, present and future infringement thereof, and the right to prosecute and maintain trademark applications and the registrations for the Mark. This assignment shall be effective when Assignee receives from Assignor the fifty thousand dollars (\$50,000.00) consideration set forth above.

2. The terms of this Assignment shall be binding upon, and inure to the benefit of and be enforceable by the respective successors and permitted assigns of the parties hereto.

3. Assignor shall execute and deliver, or cause to be executed and delivered, from time to time hereafter upon Assignee's request, all such further documents and instruments and shall do and perform all such acts as may be reasonably necessary to give full effect to the intent of this Assignment, including but not limited to all necessary documents and actions to reflect this Assignment with the United States Patent and Trademark Office, and the equivalent office in any state in which Assignee may choose to register the Mark. Assignee shall be responsible for any and all costs and expenses associated with recording this Assignment with the applicable trademark office(s).

4. This Assignment shall be governed by, and construed in accordance with the law of Delaware applicable to contracts to be performed therein, without regard to its rules on conflicts of laws.

5. Any notice or other communication required or permitted to be made or given to either party shall be sufficiently made or given on the date of mailing if sent to such party by registered or certified mail, postage prepaid, or by overnight delivery by a nationally recognized carrier, addressed to a party at its address set forth below, or to such other address as the party may designate by written notice given to the other party.


