- Synchronization Scheme: A synchronization scheme is provided that includes querying a managed device to obtain an initial device state, synchronizing the device state in a plurality of management processes, detecting a change in the initial device state, and maintaining a synchronized current device state between the managed device and the plurality of management processes. Reef Point's application was rejected by the PTO due to the existence of prior art. Although Reef Point disputed this position, it decided not to pursue further action.
- Efficient Counter Retrieval: A method and system include collecting information in a network device, determining in the network device when to send a subset of the collected information to a collection system, and determining in the network device a subset of the collected information to be transmitted at a given time. Reef Point's application was rejected by the PTO due to the existence of prior art. Although Reef Point disputed this position, it decided not to pursue further action.
- Statistics Updating System: A method and system for high speed statistics entry updating, in which related statistics entries are interleaved, portions of statistics entries are stored using a one-to-one mapping function between the pairs and to maximize parallelism between storage devices, and updating only the needed portions of a multi-word statistics entry. Reef Point's application was rejected by the PTO due to the existence of prior art. Although Reef Point disputed this position, it decided not to pursue further action.
