## TRADE MARK ASSIGNMENT

WHEREAS, fx Life Sciences International GmbH, the full post office address of whose principal office or place of business is Grafenastrasse 11, 6300 Cham, Switzerland whose previous address was Baarerstrasse 135, 6301 Zug, Switzerland, (hereinafter "the ASSIGNOR"), is the sole owner of the trade marks set forth in Schedule "A" attached to this assignment.

WHEREAS, fx Life Sciences AG, a body corporate incorporated under the laws of Switzerland the full post office address of whose principal office or place of business is Grafenastrasse 11, 6300 Cham, Switzerland (hereinafter "the ASSIGNEE"), is desirous of acquiring the entire right, title and interest in the trade-marks referred to in Schedule A, including the goodwill of the business in which the trade marks are used.

WHEREAS the ASSIGNEE is a successor to the ongoing and existing business of the ASSIGNOR, or portion thereof, to which the trade-marks identified in Section (a) and (b) below pertain.

NOW THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, in accordance with the IP Purchase Agreement between ASSIGNOR and ASSIGNEE executed previously, ASSIGNOR confirms that IP purchase agreement and does hereby sell, assign and transfer to ASSIGNEE, its successors and assigns forever:

- (a) all its right, title and interest in, to and under the trade marks listed in Schedule "A", including, for each listed country, the goodwill associated with the listed mark in that country.
- (b) in all countries other than Canada, all its right, title and interest in, to and under any

unregistered trade marks similar to the trade marks set forth in section (a) above, or any part thereof, owned by the ASSIGNOR or to which the ASSIGNOR has the right to assign, and in and to the goodwill of the business in the country, other than Canada, in which the unregistered trade marks are used.

ASSIGNOR hereby sells, assigns, and conveys to ASSIGNEE all claims by reason of past infringement of the said trade marks referred to in Sections (a) and (b) above, including the right to sue for and collect for said past infringements and including the right to commence, continue or defend oppositions based on said trade marks;

ASSIGNOR hereby authorizes and requests any official of any foreign country whose duty it is to register trade marks on said applications, to issue all trade marks listed in Schedule A to the ASSIGNEE, its successors and assigns, in accordance with the terms of this Assignment;

ASSIGNOR hereby covenants that it has the right to convey the entire right, title and interest to ASSIGNEE, herein assigned, and that it has not executed, and will not execute, any agreement in conflict therewith;

ASSIGNOR hereby agrees that it will, without further consideration, communicate with and provide to ASSIGNEE, its successors and assigns, all facts known and documents available to ASSIGNOR relating to the trade marks referred to in Sections (a) and (b) above, including the histories thereof; testify in any legal proceedings; execute and secure all papers that may be necessary to file, prosecute and maintain said trade mark applications in any country and to assign the same; make all rightful oaths; and generally do everything possible to aid ASSIGNEE, its successors, assigns and nominees, to obtain, uphold and enforce proper trade mark protection in all countries concerned in this assignment.
