The Company agrees to execute and deliver at the request of Buyer, all reasonably necessary documents, instruments and assignments, and to perform any other reasonable acts the Buyer may reasonably require in order to vest all of the Company's right, title, and interest in and to the Company Patents and Trademarks in Buyer and/or to provide reasonable evidence to reasonably support the foregoing in the event such evidence is reasonably deemed necessary by Buyer, to the extent such evidence is in the possession or control of the Company.

This Assignment of Patents and Trademarks is executed and delivered pursuant and subject to Purchase Agreement. Reference is hereby made to the Purchase Agreement for further particulars with reference to Buyer's rights in, to, and with respect to said Company Trademarks and other assets.


