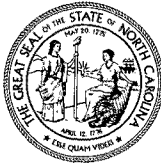
1. The name of the corporation is: **RBC CENTURA BANK**


