CONTRIBUTION AGREEMENT

This Agreement is entered into as of December 31, 2007, by and between CAREMARK RX, L.L.C., a Delaware limited liability company ("Subsidiary"), and CVS PHARMACY, INC., a Rhode Island corporation ("Company").

RECITALS

WHEREAS, Company is implementing a reorganization of numerous direct and indirect subsidiaries in order to generate economic and operational efficiencies in its business (the "Reorganization"), which Reorganization will include the merger of several of its direct and indirect subsidiaries into Company and into other direct or indirect subsidiaries of Company; and

WHEREAS, in connection with the Reorganization, the Subsidiary has authorized the contribution to Company of all of Subsidiary's right, title and interest in the Contributed Assets (as defined herein) pursuant to prior written consent of the Sole Member of Subsidiary.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The Subsidiary hereby contributes, assigns, transfers, conveys and delivers to Company, and Company hereby accepts and takes from Subsidiary, all of Subsidiary's right, title and interest in and to the Contributed Assets, effective as of December 31, 2007 (the "Closing Date"). "Contributed Assets" means all of the trademarks listed on the attached Exhibit "A".

2. Representations, Warranties and Covenants of Subsidiary.

Subsidiary represents, warrants and covenants to Company that:

(a) Subsidiary is a limited liability company, duly organized, validly existing and in good standing in the State of Delaware.

(b) Subsidiary has all requisite power and authority to execute and deliver this Agreement and to perform its obligations hereunder.

(c) This Agreement and the other documents entered into by Subsidiary in connection herewith each constitutes valid and binding obligations of Subsidiary, enforceable against Subsidiary in accordance with its terms.

(d) The execution and delivery of this Agreement and the consummation of the transactions contemplated in this Agreement do not constitute, and with the passage of time will not constitute, a default under any term or provision of its certificate of formation, operating agreement,

or any applicable law, regulation, rule, court order, judgment or material agreement to which the Subsidiary is a party or by which it or any of the Contributed Assets are bound or subject.

(c) To the best of Subsidiary's knowledge, there are (i) no pending or threatened suits or proceedings, at law or in equity, or before or by any governmental agency or arbitrator which could reasonably be expected to have a material adverse effect on the Contributed Assets taken as a whole, and (ii) no actions or investigations pending against Subsidiary under which Subsidiary would be prevented from the consummation of the contribution contemplated herein.

3. Representations, Warranties and Covenants of Company.

Company represents, warrants and covenants to Subsidiary that:

(a) Company has all requisite power and authority to execute and deliver this Agreement and to perform its obligations hereunder.

(b) This Agreement constitutes valid and binding obligations of Company, enforceable against Company in accordance with its terms.

(c) The execution and delivery of this Agreement and the consummation of the transactions contemplated in this Agreement do not constitute, or with the passage of time will not constitute, a default under any material agreement to which the Company is a party or by which it is bound.

4. Further Assurances and Instruments. From time to time after the Closing Date, Subsidiary and Company shall, without further consideration, execute, acknowledge, and deliver to the other such further instruments of assignment, transfer and conveyance and take such other actions as either party may reasonably request to assure the nature of the transaction contemplated under this Agreement. Subsidiary hereby constitutes and appoints Company, effective on the Closing Date, its successors and assigns, the true and lawful attorney of Subsidiary in the name of Subsidiary or in its own name acting for the benefit of Subsidiary to take all action that Company may reasonably deem proper in order to provide Company the benefits of the Contributed Assets.

5. General Provisions.

(a) No Waiver. Waiver of any provision of this Agreement, in whole or in part, in any one instance shall not constitute a waiver of any other provision in the same instance, nor any waiver of the same provision in another instance, but each provision shall continue in full force and effect with respect to any other then-existing or subsequent breach.

(b) Notice. Any notice, delivery or other communications required or permitted under this Agreement shall be given in writing by postage prepaid, United States first class, registered or certified mail, return receipt requested, or by mutually recognized carrier, to the parties at the following addresses. Notice shall be effective upon receipt.


(c) Miscellaneous. This Agreement (i) shall be governed by and construed in all respects under the laws of the State of Delaware, without application of principles of conflicts of law and legal action brought hereunder shall be brought in courts, federal or state, in the State of Delaware and the parties agree to the jurisdiction of such courts; (ii) constitutes the entire agreement of the parties with respect to its subject matter superseding all prior oral and written communications, proposals, negotiations, representations, understandings, courses of dealing, agreements, contracts, and the like between the parties in such respect; (iii) may be amended, modified, or terminated, and any right under this Agreement may be waived in whole or in part, only by a writing signed by both parties of this Agreement; (iv) may be executed in two or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument; (v) contains headings only for convenience, which headings do not form part, and shall not be used in construction of this Agreement; (vi) shall bind and inure to the benefit of the parties and their successors and assigns, except that no party may delegate any of its obligations under this Agreement or assign this Agreement, without the prior written consent of the other party; and (vii) all Schedules and Exhibits attached to this Agreement are made a part hereof as though fully set forth herein.
