## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is effective as of November 8, 2007, by and among F.A. Products L.P., a Delaware limited partnership having a principal place of business at 15200 Interstate Highway 45 North, Houston, TX, 77090 ("F.A. Products"), First Aid Products, Inc., a Delaware corporation having a principal place of business at 15200 Interstate Highway 45 North, Houston, TX, 77090 ("First Aid," and together with F.A. Products, "Sellers") and Derma First Aid Products, Inc., a Pennsylvania corporation having a principal place of business at 214 Carnegie Center, Suite 100, Princeton, NJ 08540 ("Buyer").

WHEREAS, Sellers hold all right, title and interest in and to the trademarks, service marks and trade names set forth on Exhibit A attached hereto and incorporated herein by reference (the "Marks"); and

WHEREAS, Sellers and Buyer are parties to that certain Asset Purchase Agreement, dated November 8, 2007 (the "Asset Purchase Agreement"), pursuant to which Sellers sold to Buyer, and Buyer acquired from Sellers, all right, title and interest to and in all of the assets described therein, including, without limitation, the rights in the Marks, together with the goodwill of the business symbolized thereby.

NOW, THEREFORE, in consideration of the premises set forth above and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Sellers do hereby sell, assign, convey and transfer unto Buyer and its successors, assigns and legal representatives, Sellers' entire right, title and interest in and throughout the United States of America, its territories and all foreign countries, in and to the Marks (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Buyer, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Buyer's sole use and enjoyment.

Sellers further authorize the Director of the United States Patent & Trademark Office, and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of Buyer, its successors, legal representatives and assigns in accordance with the terms of this instrument.

Buyer and Sellers also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Buyer and Sellers.
