**ASSIGNMENT OF  
TRADEMARK SECURITY AGREEMENT**

THIS ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (this "Assignment") is made as of October 31, 2008, between JPMORGAN CHASE BANK, N.A., a national banking association, having an address at 80 West Broadway, Suite 200, Salt Lake City, Utah 84101 ("Assignor"), and CHASE LINCOLN FIRST COMMERCIAL CORPORATION, a Delaware corporation, having an address at 80 West Broadway, Suite 200, Salt Lake City, Utah 84101 ("Assignee"). Assignor and Assignee are referred to in this Assignment collectively as the "Parties."

FOR THE SUM OF TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Parties agree as follows:

1. Trademark Security Agreement. As used in this Assignment, "Trademark Security Agreement" means that certain Trademark Security Agreement dated as of June 21, 2006 by and among 4LIFE RESEARCH, LLC, a Utah limited liability company, and 4LIFE TRADEMARKS, LLC, a Utah limited liability company (individually and collectively, as the context requires, the "Debtor"), and Assignor, as "Secured Party", which was recorded with the United States Patent and Trademark Office on June 27, 2006 at Reel/Frame 003337/0882. Capitalized terms used but not defined in this Assignment shall have the meanings assigned to such terms in the Trademark Security Agreement.

2. Purpose of Assignment. Assignor desires to assign to Assignee all of Assignor's right, title and interest under the Trademark Security Agreement, and Assignee is willing to accept such assignment, each pursuant to that certain Omnibus Assignment of even date herewith between Assignor and Assignee.

3. Assignment. Assignor assigns and transfers to Assignee all of Assignor's right, title and interest as the Secured Party under the Trademark Security Agreement in and to the Collateral described in the Trademark Security Agreement, including, without limitation, the marks, names and applications described on Schedule A attached hereto. Assignee accepts the foregoing assignment and assumes and agrees to be bound by all of the terms, covenants and conditions to be performed on and after the date of this Assignment by the Secured Party under the Trademark Security Agreement.



This Assignment shall be governed by, and construed in accordance with, the laws of the State of Utah, except as required by mandatory provisions of law or to the extent the perfection or priority of the security interests hereunder, or the remedies hereunder, in respect of any Collateral are governed by the law of a jurisdiction other than the State of Utah. This Assignment may be executed in any number of duplicate originals or counterparts, each of which when so executed shall constitute in the aggregate but one and the same document.






