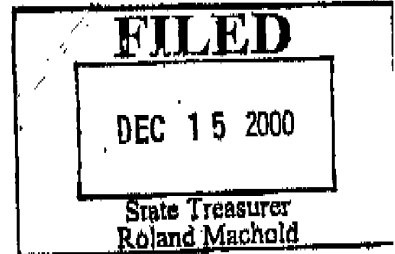

**CERTIFICATE OF AMENDMENT
TO
CERTIFICATE OF INCORPORATION
OF
LAJOBI SALES, INC.**



*Pursuant to N.J.S.A. Sections 14A:9-1, 14A:9-2(4) and 14A:9-4(3)
of the New Jersey Business Corporation Act*

The undersigned President of LaJobi Sales, Inc. (the "Corporation") does hereby state that:

1. The name of the Corporation is "LaJobi Sales, Inc."
2. The following amendment to the Certificate of Incorporation of the Corporation (the "Certificate Of Incorporation") was unanimously approved by the Board of Directors of the Corporation and thereafter duly unanimously adopted by the Shareholders of the Corporation on the 9th day of November, 2000.
3. The amendment of the Certificate of Incorporation effected by this Certificate of Amendment is that Paragraph 1 of the Certificate of Incorporation shall be deleted in its entirety and replaced by the following language;

"The name of the corporation is LaJobi Industries, Inc."

4. The total number of the Corporation's shares outstanding at the time of adoption of this Certificate of Amendment was one hundred (100), and the total number of such shares entitled to vote thereon was one hundred (100).
5. The total number of shares voting in favor of such amendment was one hundred (100).
