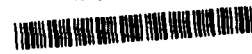
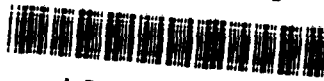



desirable to vest all right, title and interest in and to THE REGISTRATIONS in FAPLP.


