WHEREAS, Assignor is also the sole owner of the entire right, title and interest in and to the following common law unregistered trademark:


DURA SUITE, for computer programs relating to the construction of residential homes (all three of the aforementioned marks hereinafter collectively referred to as "the Marks"); and
