ASSIGNMENT

WHEREAS, ARGON MEDICAL DEVICES, INC., a Delaware corporation, with an address of 272 East Deerpath Road, Suite 316, Lake Forest, Illinois 60045, (hereinafter "ARGON"), is the owner of the trademark CLEARVIEW, Registration No. 1,973,681, registered in the United States Patent and Trademark Office on May 14, 1996, including all common law rights and other nonregistered rights associated therewith (hereinafter "CLEARVIEW"); and,

WHEREAS, CLINICAL INNOVATIONS, LLC, a Delaware limited liability company, with an address of 272 East Deerpath Road, Suite 316, Lake Forest, Illinois, 60045 (hereinafter "CLINICAL"), is desirous of acquiring the CLEARVIEW trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ARGON does hereby sell and assign to CLINICAL all right, title and interest in, to and under the CLEARVIEW trademark, together with all common law rights connected thereto, and to the goodwill of the business relating thereto and symbolized by the CLEARVIEW trademark.

ARGON further transfers, assigns and sets over to CLINICAL, free and clear of any claims, liens and encumbrances, all of ARGON's right, title and interest, legal and equitable, in and to any claims, causes of action for past, present and future infringements of the CLEARVIEW trademark and for unfair competition and any related claims ARGON may have against any third parties, whether known or unknown, and to apply any damages recovered to CLINICAL's account.

ARGON covenants to cooperate with CLINICAL, or its designees or legal representatives, to bring and maintain any such claims or causes of action, whether in a court of competent jurisdiction or in an administrative agency, and ARGON shall provide any documents, records and things necessary to maintain any and all claims or causes of action upon reasonable request of CLINICAL, its designee or legal representative.

ARGON covenants and agrees to execute and cause to be execute, at the request of CLINICAL, or its designees, successors, assigns or legal representatives, all assignments, powers of attorney, and other papers as may be reasonably necessary to enable CLINICAL to obtain or maintain the CLEARVIEW trademark herein conveyed or intended to be conveyed.

IN WITNESS WHEREOF, ARGON has caused this instrument to be executed by its duly authorized corporate officer as of the 30th day of October, 2008.

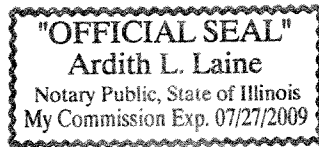
