WHEREAS, Source Gas Distribution LLC, a Delaware limited liability company (hereinafter "Source Gas"), is desirous of acquiring all right, title and interest in and to the Marks and the goodwill and other rights and powers appurtenant thereto;

WHEREAS, in connection with the Purchase and Sale Agreement, dated as of August 14, 2006, by and among Kinder Morgan, Source Gas LLC, a Delaware limited liability company (as the assignee of Aircraft Services Corporation, a Nevada corporation) ("SGLLC"), and Source Gas Inc., a Delaware corporation (as the assignee of SGLLC), as amended, Kinder Morgan is desirous of transferring all right, title and interest in and to the Marks and the goodwill and other rights and powers appurtenant thereto;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

Kinder Morgan hereby, assigns, conveys, and transfers to Source Gas all right, title, and interest in and to the Marks, and the trademark registrations and any common law rights in the Marks, together with any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present or future infringements thereof, and all rights corresponding thereto, together with the goodwill of the business appurtenant thereto.

Kinder Morgan hereby authorizes the Commissioner of Patents and Trademarks of the United States, and the empowered officials of all governments anywhere in the world, to issue or transfer all of the Marks listed herein to Source Gas and to record Source Gas as assignee of the entire right, title and interest therein.

Kinder Morgan hereby appoints Source Gas as its attorney-in-fact to act in Kinder Morgan's name, place and stead to execute, deliver and record any document or instrument of assignment

required in any country where the Marks listed herein are used, pending or issued, granting or confirming the rights granted herein. Kinder Morgan agrees that it shall, at Source Gas's request, execute all documents reasonably necessary to perfect Source Gas's title to the Marks.

This assignment shall be binding upon the successors and assigns of Kinder Morgan and shall inure to the benefit of the successors and assigns of Source Gas.

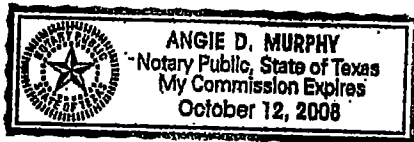
