ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark and the Property, together with the goodwill of the business connected with and symbolized by the Mark and for which the Mark is registered (including, without limitation, the right to renew any registrations of the Mark, the right to apply for registrations within or outside the United States based in whole or in part upon the Mark, and any priority right that may arise from the Mark); all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past, present or future infringements and misappropriations of the Mark.

ASSIGNOR authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration set forth on Exhibit A to ASSIGNEE as assignee of ASSIGNOR's entire right, title and interest therein.

ASSIGNOR will authorize and direct, and hereby authorizes and directs, its attorneys, agents and representative having custody or control of any documents, including any computerized files, relating to the Mark or the Property, upon presentation hereof, to deliver such documents to ASSIGNEE or such person as ASSIGNEE may designate in writing.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark and the Property.
