RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF TRADEMARKS ("Release") is made effective as of November 5, 2008 by RBS Citizens NA successor by merger to Citizens Bank of MA successor to State Street Bank and Trust Company (the "Lender") to Tender Corporation, (the "Borrower"), as follows:

WHEREAS, on March 20, 1991, the Borrower and the Lender entered into a Collateral Assignment of Trademarks ("Security Agreement");


