WHEREAS, default in the payment of principal and interest has occurred under the terms of a Promissory Note (the "Note") dated April 1, 2005 (as later amended and restated) which was executed and delivered by Teton Homes Corporation, a Delaware corporation, to Zions First National Bank, N.A., which Note was secured by a Security Agreement (the "Security Agreement"), with respect to which a Financing Statement was filed on April 6, 2005, as Number 51126763 in the Delaware Department of State, and by a First Mortgage and Security Agreement and Fixture Financing Statement with Assignment of Leases and Rents (the "Mortgage"), which was recorded on April 4, 2005, as Instrument No. 763821 in the records of the office of the County Clerk and ex-officio Register of Deeds in and for Natrona County, State of Wyoming; and

WHEREAS, written notice of default has been given to Teton Homes Corporation; and

WHEREAS, the Security Agreement, the Mortgage and the Wyoming Uniform Commercial Code contain a power of sale which, by reason of said default, has become operative; and

WHEREAS the amount due upon the Note is \$6,475,408.30 as of September 3, 2008 (which amount consists of the unpaid principal balance of \$6,397,430.69 plus interest of \$77,977.61) plus interest, attorney's fees, costs expended and late charges continuing to accrue (the "Indebtedness"); and
