Pursuant to the provisions of Section 48-21-105 of the Tennessee Business Corporation Act, the undersigned corporations adopt the following articles of merger:

1. The attached Agreement and Plan of Merger was approved by each of the undersigned corporations in the manner as prescribed by the California Corporations Code and the Tennessee Business Corporation Act.

2. As to Sheffield Enterprises, Inc., a California corporation, the plan was duly adopted on July 31, 1997 by written consent of the trustee of that certain Voting Trust Agreement dated March 15, 1988 which gives the trustee all voting rights of shares registered in the name of the trustee. As of the date hereof, all 300 shares of common stock outstanding are registered in the name of the trustee.

3. As to Sheffield Group Enterprises, Inc., a Tennessee corporation, the plan was duly adopted on July 31, 1997 by written consent of the trustee of that certain Voting Trust Agreement dated July 31, 1997 which gives the trustee all voting rights of shares registered in the name of the trustee. As of the date hereof, all 300 shares of common stock outstanding are registered in the name of the trustee.

4. The merger will be effective as of the date and time of filing of these articles of merger with the Secretary of State of Tennessee.
