

**ASSIGNMENT OF COMMON LAW TRADEMARKS,
TRADEMARK REGISTRATIONS AND APPLICATIONS FOR REGISTRATION**

THIS TRADEMARK ASSIGNMENT is made as of the 16th day of October, 2008, between Cardan Design Corporation, a New Jersey corporation ("Assignor"), and Techni-Edge Manufacturing Corporation, a New Jersey corporation (the "Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of United States and foreign trademark registrations, applications for United States and foreign trademark registrations and United States and foreign common law trademarks, including, but not limited to, the trademark registrations and applications for trademark registration identified on Schedule A attached hereto; and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest of the Assignor in and to all United States and foreign trademark registrations, applications for United States and foreign trademark registrations and United States and foreign common law trademarks owned, in whole or in part, by Assignor and relating to the business of Assignor identified on Schedule A, including the goodwill associated therewith (hereinafter "the Trademarks");

NOW, THEREFORE, in consideration of the sum of One dollar (\$1.00) and other good and valuable consideration not herein specifically enumerated, the receipt and sufficiency of which is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does hereby sell, assign and transfer unto the Assignee, its successors, assigns or other legal representatives, its entire right, title and interest in and to the Trademarks, including the goodwill associated therewith.


The foregoing assignment and transfer shall include all claims for profits and damages by reason of past infringement, if any, of the Trademarks, with the right to sue for and collect the same for the Assignee's own use and advantage and for the use and advantage of its successors, assigns or other legal representatives.

Assignor further covenants and agrees that it will at any time, upon the request of Assignee, its successors, assigns or legal representatives, execute and deliver to Assignee all further documents which may be necessary for recording in particular jurisdictions of Assignee's title in and to the Trademarks, including all confirmatory assignments and all other necessary or supplementary papers which may be required to confirm, perfect or record this title.

Assignor hereby relinquishes to Assignee all responsibility for future maintenance of protection of the Trademarks which may be required, including but not limited to prosecuting infringement and filing applications and paying fees due to the United States Patent and Trademark Office and/or any state, local or international body for trademark protection.

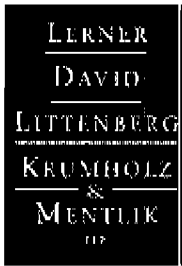
