OF SECURITY INTERESTS  
IN CERTAIN TRADEMARKS  
NUNC PRO TUNC**

**TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS NUNC PRO TUNC** (this "**Release**"), executed on November 17, 2008 and effective as of January 14, 2004, by **THE PRUDENTIAL INSURANCE COMPANY OF AMERICA**, as collateral agent (the "**Collateral Agent**").

**WHEREAS**, pursuant to the terms of that certain Security Agreement, dated as of June 20, 2000 (as amended and in effect from time to time, the "**Security Agreement**"), by each of Prince Communications, Ltd. (together with its successors and assigns, the "**Company**"), The Printing House, Ltd. (together with its successors and assigns, "**PHL**"), PCL Media, Ltd. (together with its successors and assigns, "**PCL**"), Homes & Land Publishing, Ltd. (together with its successors and assigns, "**H&L**") and Prince Communications Publishing, Inc. (together with its successors and assigns, "**PCP**", and, together with PHL, PCL, and H&L, individually, a "**Guarantor**," and collectively, the "**Guarantors**"; and the Company and the Guarantors individually, an "**Obligor**," and collectively, the "**Obligors**"), in favor of the Collateral Agent, and recorded with the United States Patent and Trademark Office, for the purpose of securing certain obligations of the Obligors to the Collateral Agent, the Obligors granted to the Collateral Agent a security interest in and lien on, and collaterally assigned to the Collateral Agent all of their respective trademarks, trademark registrations, trademark applications and associated goodwill, including, without limitation, the trademarks, trademark registrations and trademark applications identified on Exhibit A attached hereto (such trademarks referred to herein as the "**Named Trademarks**"); and

**WHEREAS**, as of January 14, 2004, the Collateral Agent agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

**WHEREAS**, the Collateral Agent and Obligors now desire to enter into this Release formalizing the prior termination and release of security interests in the Named Trademarks in a form acceptable for recordation by the United States Patent and Trademark Office;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent and the Obligors hereby agree as follows:

1. **Release and Assignment.** The Collateral Agent hereby terminates and releases its security interest in and first priority lien on all of the Named Trademarks, and the Collateral Agent hereby assigns and transfers to the Obligors, without recourse, all of the Collateral Agent's right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill. This termination and release is expressly made Nunc Pro Tunc and shall have the same legal force and effect as if executed on January 14, 2004.

2. **Acknowledgment and Acceptance.** The Obligors hereby acknowledge and accept the foregoing release and assignment by the Collateral Agent.

3. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.




