TRADEMARK ASSIGNMENT

WHEREAS, iKobo, Inc., having its principal office located at 2030 Powers Ferry Road, Atlanta Georgia 30339, hereinafter "**ASSIGNOR**," has adopted, used, licensed use, is using and is the owner of all right, title and interest in and to, including, all common law rights whether federal or state, the United States Patent & Trademark Office Trademark Registration No. 2,859,415 pertaining to the word mark IKOBO (the "**Mark**"); and

NOW, THEREFORE, in consideration of the sums paid by ASSIGNEE pursuant to the Asset Purchase Agreement and other good and valuable consideration, the receipt and adequacy of which are hereby mutually acknowledged, ASSIGNOR hereby irrevocably sells, assigns, transfers and conveys unto ASSIGNEE, its successors and assigns, all right, title and interest, if any, in and to: (a) the Mark and the term iKOBO; (b) any and all registrations of the Mark; (c) all common law rights in, to and under the Mark; (d) all other rights in, to and under the Mark, together with the goodwill of the business symbolized by the Mark; (e) any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Mark and/or the goodwill under the Mark; and (f) all claims or causes of action ASSIGNOR has or may

have in connection with the Mark, including, but not limited to, the right to sue and recover damages for any and all past infringements of any of the Mark.
