**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL  
AND PATENT COLLATERAL**

**THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL AND PATENT COLLATERAL** (this "Partial Release") is made as of November 17, 2008 ("Effective Date") by **Sun Mackie LLC**, a Delaware limited liability company, with its principal office at 5200 Town Center Circle, Boca Raton, Florida 33486 (together with its successors and assigns, if any, in such capacity the "Secured Party").

**WHEREAS**, reference is made to (i) that certain Senior Subordinated Promissory Note dated as of October 19, 2006 (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the "Subordinated Note") executed by **Loud Technologies Inc.**, a Washington corporation ("Borrower"), and issued in favor of the Secured Party, and (ii) that certain Security Agreement dated March 18, 2008 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement") by and among the grantors listed on the signature pages thereof and those additional entities that thereafter became parties thereto (collectively, jointly and severally, the "Grantors" and each individually a "Grantor") and Secured Party;

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement, Grantors executed and delivered to the Secured Party that certain Trademark Security Agreement dated March 18, 2008 (the "Trademark Security Agreement") and that certain Patent Security Agreement dated March 18, 2008 (the "Patent Security Agreement");

**WHEREAS**, pursuant to the terms and conditions of the Trademark Security Agreement, Grantors granted to the Secured Party a continuing priority security interest in and to all of Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

**WHEREAS**, pursuant to the terms and conditions of the Patent Security Agreement, Grantors granted to the Secured Party a continuing priority security interest in and to all of Grantors' right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement);

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on April 2, 2008 at Reel/Frame 3751/0481;

**WHEREAS**, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on April 3, 2008 at Reel/Frame 020753/0350; and


**WHEREAS**, the Grantors have requested that the Secured Party release its security interest in and to (a) the trademark registrations set forth on Schedule A hereto, in each case, together with the goodwill associated therewith (the "Released Trademark Collateral") and (b) the United States patents set forth on Schedule B hereto (the "Released Patent Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby RELEASES its security interest in and to the Released Trademark Collateral and the Released Patent Collateral. The Secured Party hereby agrees to take such further actions and to execute and deliver such further documents as the Grantors may reasonably request, and at the Grantors' sole cost and expense, to effect and evidence the Secured Party's release of its security interest in and to the Released Trademark Collateral and the Released Patent Collateral.
