ASSIGNMENT AGREEMENT

This **ASSIGNMENT AGREEMENT** ("Agreement"), effective as of the 6 day of October, 2008, is made and entered into by and between Revolution Health Group, LLC, a Delaware limited liability company having a place of business at 1717 Rhode Island Ave, NW, Suite 1000, Washington DC, 20036, ("Assignor") and WF Holding Company LLC, a Delaware limited liability company having a place of business at 1717 Rhode Island Ave, NW, Suite 1000, Washington DC, 20036 ("Assignee").

RECITALS:

A. Assignor has acquired and owns certain rights, title, and interest in and to domain names, trade names, trademarks, and service marks that contain the words REVOLUTION REWARDS and REVOLUTIONREWARDS (collectively, the "REVOLUTION REWARDS Marks"); and


B. Assignee seeks to acquire all rights, title, and interest existing anywhere in the world that Assignor owns in and to any domain name, trade name, trademark, or service mark that contains the REVOLUTION REWARDS Marks, as well as any applications or registrations for the REVOLUTION REWARDS Marks, including the application listed on Exhibit A, together with the goodwill of the business symbolized by the REVOLUTION REWARDS Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, conveys, and delivers to Assignee all right, title, and interest existing anywhere in the world in and to the REVOLUTION REWARDS Marks, (the "Assignment"), including (i) all rights therein provided by international conventions or treaties, (ii) any and all goodwill of the business symbolized by the REVOLUTION REWARDS Marks, (iii) all applications, registrations, renewals and extensions of registrations thereof that may be secured under the laws of any jurisdiction, and (iv) any and all rights to sue or recover and retain damages and costs and attorneys' fees for past, present, and future infringement, dilution, misappropriation, or other violation thereof, and rights of priority and protection of interests therein under the laws of any jurisdiction. The Assignment contained herein shall not be deemed to include an assumption by Assignee of any liabilities of the Assignor.

This assignment of the REVOLUTION REWARDS Marks to Assignee is a full and complete transfer of all of Assignor's right, title, and interest in and to the REVOLUTION REWARDS Marks and for the full duration of such rights, including all intellectual property rights of any nature relating to the REVOLUTION REWARDS Marks and all pending applications and registrations thereof that might exist, and for each individual asset the common law rights and goodwill associated therewith.

At the request of Assignee, Assignor shall execute and deliver such documents or take such other actions as Assignee or its counsel may reasonably request to effectuate the purposes of this Agreement.


