ASSIGNMENT OF TRADEMARK

This Assignment of Trademark (the "Assignment") is made and entered on this 6th day of November, 2008, by and between Everest Biomedical Instruments Company, a corporation existing under the laws of the State of Delaware, having an address of 2825 Airview Boulevard, Kalamazoo, Michigan 49002, United States of America, formerly of 16690 Swingley Ridge Road, Suite 140, Chesterfield, Missouri 63017 United States of America ("Assignor") and Stryker Corporation, a corporation existing under the laws of the State of Michigan, having an address of 2825 Airview Boulevard, Kalamazoo, Michigan 49002, United States of America, ("Assignee") (collectively referred to as the "Parties").

Whereas, Assignor is the owner of the trademarks described in Exhibit A attached hereto and incorporated by reference herein (the "Marks"); and

Whereas, Assignor wishes to assign its rights in the Marks to Assignee.

Now, Therefore, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. ASSIGNMENT: Assignor hereby assigns, sells and transfers to Assignee all of its rights, title and interest in and to the Marks, including, but not limited to: (i) all registration rights with respect to the Marks, (ii) any rights to prepare derivative marks, (iii) any goodwill related to the Marks, and (iv) all income, royalties or claims relating to the Marks due or payable on or after the date of this Assignment.

2. ASSIGNOR'S REPRESENTATIONS: Assignor represents and warrants (i) that Assignor is the exclusive owner of the Marks, (ii) that Assignor possesses all rights, title and interest in and to the Marks, (iii) that Assignor has the power to enter into this Assignment, (iv) that the Marks do not infringe on the rights of any other person or entity, and (v) that the rights transferred in this Assignment are free of any lien, encumbrance or adverse claim.

3. CONTINUING OBLIGATIONS: Assignor agrees to assist Assignee, upon request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of this Assignment.

4. BINDING EFFECT: The covenants and conditions contained in this Assignment shall apply to and bind the Parties and their heirs, legal representatives, successors and permitted assigns.

5. GOVERNING LAW: This Assignment shall be governed by and construed in accordance with the laws of the State of Michigan.
