wishes to accept such assignment;



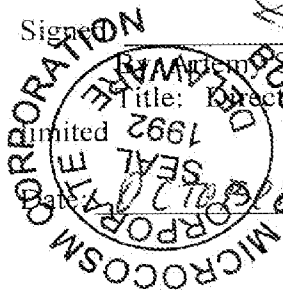


